BE IT RESOLVED THAT: following a presentation from representatives from the *Children First Committee* on the topic of closing Morison School, the Council of the United Townships of Head, Clara & Maria does hereby request the Province of Ontario and the Minister of Education in particular, to implement a moratorium on all disputed school closings and especially Morison Public School in the Town of Deep River part of the Renfrew County Public School Board, until a full review of funding to rural and small community schools be implemented with transparency.

AND BE IT FURTHER RESOLVED THAT this Council does request the Minister of Education to appoint a facilitator, similar to and with the same power as the one appointed in 2005 for the same school, to investigate, report and make recommendations on the funding and closing of Morison School prior to any action being taken to close the school.

WHEREAS the Library Board of the United Townships of Head, Clara & Maria has contacted this Council with a request for support for continued provincial funding for the Knowledge Ontario program;

AND WHEREAS Knowledge Ontario's tools such as: *Resource Ontario; Ask Ontario; Connect Ontario; Our Ontario* and *Learn Ontario* which focus on access to digital information, personalized research assistance, access to digitized historical and cultural collections and access to literacy through tutorials provide a necessary link to the digitalized information web for our rural residents;

AND WHEREAS the Council of the United Townships of Head, Clara & Maria fully agrees that the information and services provided by Knowledge Ontario are essential and that continued funding is critical to small municipalities like ours to allow our Boards to continue to provide connectivity, education and services to our residents;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby request that the provincial government sincerely commit to continued funding for Knowledge Ontario and the programs and services that it provides. Without Knowledge Ontario there would be a huge gap in what small municipalities like ours would be able to provide to its rural residents.

BE IT FURTHER RESOLVED THAT this resolution be forwarded to our MPP, John Yakabuski; David Thornley, Executive Director, Knowledge Ontario; David Allen, CEO, Federation of Public Libraries of Ontario; AMO, all local municipalities and the HCM Public Library Board.
