**Subject:** Location of post office boxes in Stonecliffe.

**RECOMMENDATION:** That Council recommend to Canada Post the locations for the mail boxes either beside the municipal garage, near the recycling bin (Point B on the map) or along the paved section of the office parking lot, between the office windows and the exterior library entrance (Point A on the map).

WHEREAS Council has advised Canada Post that Post office boxes would be the preferred method of delivery in the event of a failure to reach an agreement with Yates store for service;

**AND WHEREAS** a representative of Canada Post visited our offices and proposed a number of options for consideration;

AND WHEREAS the viable options to be considered include:

- 1. On the east side of the garage next to the recycling bin;
- 2. On the west side of the garage facing the Memorial;
- 3. Between the office windows and exterior library door facing the road;
- 4. Other \_\_\_\_\_;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby request that the post office boxes be placed as per option \_\_\_\_\_ above.

**BACKGROUND/EXECUTIVE SUMMARY:** Geoff Clouthier of Canada Post attended at the municipal offices and suggested a number of locations for placement of the mail boxes. Geoff would like to see the boxes placed on or near a paved surface and under existing lights if possible.

Staff have a challenge with the location near the Memorial as it is felt that the positioning of mail boxes will take away from the attractiveness of the site and have suggested options 1 and 2 above. Both of these locations are on or very near a paved surface, below lighting yet enough out of the way of snow plowing activities and the Memorial. Both are areas that are routinely cleared of snow by our Road Super.
