#### A MESSAGE FROM MAYOR GIBSON

Hello all,

I want to share with you some of the aspects of my new job as your municipal leader. We here in Renfrew County are in what is called two tier Municipal government. One is called the upper tier and that is the Renfrew County Council and the others are called lower tier and they are the member Municipalities that send a representative to the upper tier.

In Renfrew County, the city of Pembroke does not belong to County Council and is considered a single tier Municipality. However, this year, the City Of Pembroke will consider joining the County so stay tuned for those developments.

Each of the member lower tier governments sends a representative to County Council. It is this person's job to be their Municipality's spokesperson at the County level. This job automatically falls to the lower tier Head of Council unless that lower tier Council chooses otherwise. In Head Clara and Maria, the Mayor does this job as does the Mayor, John Reinwald, in our neighboring Municipality,

#### Role of Head of Council at the County Level

The head of a local or lower tier council while sitting at the county or upper tier level; is representative of his/her municipality but not it's council. This person is an individual and does not vote on behalf of the lower tier council or necessarily express their views.

Laurentian Hills. Last year the Town of Deep River created a separate position to do this job and that position is called Reeve and Glenn Doncaster was acclaimed to that position in last year's Municipal election. In Renfrew County, five member municipalities have a Reeve as their representative at County Council instead of the Head of Council. They are the Town of Arnprior, the Town of Renfrew, the Township of Laurentian Valley and the Township of Whitewater Region and the Town of Deep River.

The Townships of Brudenell, Lyndoch and Raglan is the only municipality that still calls their Head of Council a Reeve. So at County Council we have 17 people there representing their respective municipalities. 12 of them are new faces and are called either Reeve or Mayor and in our Case, we changed the name from Reeve to Mayor. The County Warden, Peter Emon, who chairs the County Council meetings, used to address the members of County Council by their Municipal title. That system was changed for a couple of very good reasons. One was that with the many changes at County Council it was somewhat difficult to remember who was a Reeve and who was a Mayor and secondly, everyone there has the primary responsibility of being a member of the upper tier Municipal government. Hence, we are all called Councillors.

Now comes the tough part of my new job. When I am Mayor Jim Gibson, my total responsibility is to our Municipality. When I am Councillor Jim Gibson sitting at County Council, my focus now has to change and I have to act in a

manner that is the best for the long term interests of Renfrew County even though those interests are different than our Municipalities.



I'll give you an example: As you all know, we no longer have an active railway running through our Municipality and the rest of Renfrew County, part of Lanark County and a part of Papineau Cameron Townships to our west.

The County has passed a resolution to direct County staff to negotiate the purchase of this abandoned railway right of way. Most of the people in this Municipality whose property abuts the rail line don't want a county trail system running through their back yard and would like the opportunity to purchase the part of the right of way that backs onto their property. I agree with them as Mayor Jim Gibson. As County Councillor Jim Gibson I agree that the purchase of this rail corridor is in the best long term interests of Renfrew County. Not a comfortable position to be in.

Hopefully I haven't bored you to death but have given you a small glimpse of what happens at the upper tier level of government.

Thanks for taking the time to read this newsletter and we'll talk with you the next edition.

# FROM YOUR TREASURER

### **FREQUENTLY ASKED QUESTIONS - PROPERTY TAX**

- What are the Property Tax Installment dates? There are 3 regular Installments each year The end of March, July and October.
- When should I receive my tax bill and what should I do if I don't? The United Townships of Head, Clara & Maria mails property tax bills twice a year. For new dwellings and additions, tax bills may also be issued throughout the year.
- a) <u>Interim Tax Bills</u>: The Interim tax bill is generally mailed out in early March. This bill is the interim levy which is based on 50% of the prior year's taxes and this one installment is due at the end of March.
- **b)** <u>Final Tax Bills</u>: The Final tax bill is generally mailed out in early July, and has two installments listed with due dates for the end of July and October.
  - It is up to the homeowner to be familiar with these dates. If you have not received a tax bill by July 31st, please contact our office; it is your legal obligation to pay your property taxes. Please note it is also the homeowner's responsibility to notify our office of any address changes to ensure you receive your tax bills in a timely fashion.

### How can I make a tax payment?

- **Scotiabank Tax Payments**: can be made by visiting any Scotiabank in Canada. If you have a Scotia account you can pay on-line or through telephone banking by adding Head, Clara Maria as a 'payee'. When using this process, you must omit the **'4798'** numbers and enter the rest of the roll number (0000010123450000).
- For non-Scotia customers, you can still make your tax payment but you must go to a Scotia Bank. You present your tax bill to the teller and let him/her know you are a non-customer; when the teller processes your payment make sure to tell them to omit the **4798** and enter the rest of the roll # (0000010123450000).
- Payments for invoices and tax payments can be made on our township website by VISA, Master Card, Amex, Discover or PayPal. Please see details below:
- Go to <u>www.townshipsofheadclaramaria.ca</u> below the picture on the website, Click on the link that states (make an epayment)- another page will open; click on Register and follow the instructions. Ensure you fill in all of the fields with the information required then click on continue.

Once registration is successful you will see a message indicating a verification message has been sent to your email address. When you receive the email, follow the instruction to verify your information and your account will be ready to use. If you haven't received the message within an hour then log in and you will be given the opportunity to have the system resend the verification message. Your verification message, and all other emails from this web site, will come from *EBill4352@jUSTInter.net*. (cont'd page 11)

### **Your Staff at Work**

HCM staff and Council work diligently to save tax dollars and make prudent purchasing decisions. We are all (save Bob Labre) HCM residents and pay taxes here too. Increasing your taxes would increase ours. Why would we want to do that?

Did you know that Bill regularly takes it upon himself to transfer materials from one disposal site to the other (while he is going there anyway) to avoid having our recycling contractor travel to pick the material up in Bissett? Or to extend the life of a cell so that both sites require compacting and cell creation at the same time, avoiding having our contractor come up here twice?

Did you know that the recreation committee is self-sustaining? That the recreation events which are being held, pay for themselves; money is not coming from your tax dollars to host them?

In 2013 staff agreed to accept and stockpile as much asphalt from the highway construction as they would give us. In 2014 Terry used this material to apply to Cotnam Road and Dunlop Crescent reducing the costs of grading, gravelling and calcium into the indefinite future. Plans for 2015 include spreading this same material on McIsaac Drive and Trapper's Road further reducing annual maintenance costs.

Did you know that in 2015 nearly \$3,000 in donations and recreation raised funds are available for community improvements?

That Bob prints forms instead of purchasing blank forms to use for Building to save costs of office supplies.

Although the process has yet to be completed, staff have worked to obtain a permanent liquor license to increase community centre use. Proceeds of the bar will pay for the extra costs of utilities and subsidize rental costs that come with additional use.

Staff have worked to come up with ideas to increase revenues including selling sweaters in the municipal office, fundraising and applying for all available grants.

Do you have any suggestions that might help save us all tax dollars? If you've learned of creative cost savings tools from other municipalities; please share them. Working together we can strive to keep HCM taxes the lowest in the County. (M Reith)

**Please add this email address** to your address book so that messages sent from it will not be blocked by any spam blocking software that you are using.

- Follow the directions in the email. (Click on the link provided in your email then you will be back to Townships of Head, Clara and Maria, on eCommerce – Account Verification.)
- You will then enter your Username, Password (this will be the username & password you entered when registering) & Verification Code (received in your email) and click on Verify.
- ◆ Another page will open. You will then have the option to choose Pay My Invoice or Pay My Property Tax Bill.
- When paying a Tax Bill, you will have to enter your complete roll number such as 47-98-000-010-12345-0000 in the box where Parcel # is. Then you will enter the amount you wish to pay. Please be aware there is a Convenience Fee that applies. The fee is charged by the company supplying our township with the software.
- ♦ When paying an Invoice, you must enter the invoice # and the amount you wish to pay. The convenience fee will also apply.
- Payments can also be made via cash, cheque or money order by visiting the township office. When visiting after-hours, payments can be dropped in our night depository slot located at the municipal office entrance. ### **BUDGET 2015**

One of the exceptions in the county, the Council of the United Townships of Head, Clara & Maria passed its budget in January of 2015. The reasoning is that it is going to cost Head, Clara & Maria the same to run our operations in 2015 no matter what the province sets the education tax rate at or what the County sets it's rate at. We already operate at such narrow margins and with few discretionary projects that our budget has little wiggle room.

Many municipalities hold off on setting their budget and/or tax rate until these other two rates are set. They then slash or add projects to make up the difference as required based on the provincial or county rates.

### Costs Municipalities have no control over

Sometimes circumstances arise which do not allow us to reduce taxes as we would like. For 2015, we worked hard to keep our budget level while considering costs outside of our control. This has resulted in Council passing a budget at \$11.78 / \$100,000 value or 4.49% less than 2014.

Annually each municipality has it's funding affected by the province through cuts or increases to the costs of provincial policing, transfer payments through the Ontario Municipal Partnership Fund, assessment phase in and for 2015-2017 special funding of at least \$25,000.

Often while the government gives with one hand it takes away with another. For 2015, the following requirements were announced, with no warning. Since approving the budget in January, the following duties have been added to Council's obligations for 2015:

"It will be required that all emergency management program coordinators, designated by their municipality, complete the following courses offered by the OFMEM in 2015.

- EM 200 Basic Emergency Management
- EM 240 Note Taking Course
- EM 300 Community Emergency Management Coordinator Course

• IMS 100 – Introduction to Incident Management System (available online)

• IMS 200 - Basic Incident Management System

In addition, all members of the Municipal Emergency Control Group are required to complete a minimum of four hours of annual training in 2015. The required training shall include instruction on note taking, continuity of operations planning and a review of specific emergency scenarios or identified local hazards." The requirements are the same no matter the size or composition of the municipality.

### Other issues which drive up the cost of municipal administration

Annually there are other circumstances which drive up the cost of municipal administration well outside of the control of any staff member or member of Council. For example, the provincial government's stance on Joint and Several Liability ensures that the cost of liability insurance for municipalities continues to skyrocket. (Please see article on page 15.)

With the provincial government not taking a stance to amend the binding arbitration process costs such as that for provincial policing continues to grow. There are many other issues which we will visit in an upcoming Newsletter.

Recently our municipal auditor completed our audit and confirms a surplus of \$178,640. For a small municipality that is a significant amount of money. Staff estimates were \$95,000 leaving a difference of \$83,640. Why?

Although a detailed question the short answer is that we realized increased revenues and didn't have the expenses we forecast. Revenues were higher partly because of the last regular payment from the rail way; higher than estimated surplus from 2013; increased revenues from account interest and penalties on overdue taxes; a special grant and payments in lieu of taxes.

Expenses were reduced in the following areas, based mainly on work/purchases not completed, weather affecting winter operations, and the conscious efforts of staff to work effectively and efficiently. A complete breakdown may be located on line under the reports for the March 27, 2015 meeting or by asking at the office.

At an upcoming meeting, Council will allocate the surplus to reserve funds for already identified Council priorities. (Next Newsletter—Funding Reserves vs. Pay as You Go)



### Re: CP Abandoned Rail Corridor Acquisition Update

The Partner municipalities (Renfrew County, Lanark County and Township of Papineau-Cameron) met with CP Rail on November 27, 2014 to discuss the acquisition of the 302 km abandoned rail corridor from Smiths Falls to Mattawa.

During the meeting CP Rail advised that railway track materials (rails, tie plates, spikes, ties, gates, signals) are now totally cleared off from Mile 1.4 (Sturgess Road in Smiths Falls) to Mile 85.9 (Meath Hill). The rest of the corridor to Mattawa is still considered a construction site which will be cleared by the end of 2015.

The Partners asked CP Rail if the municipalities or the public can work (trim weeds, cut grass, etc.) on the corridor. CP Rail advised that this may encourage locals to trespass and leave CP open to lawsuits. The land remains private property and is posted as no trespass.

The parties discussed terms of the potential purchase through a DRAFT Agreement in Principle and negotiations will continue into 2015.

The Partner municipalities are researching various issues that are contained in the Agreement in Principle and will meet again in early 2015.

### Pettapiece continues push for municipal liability insurance reform

(Queen's Park) – Perth-Wellington MPP Randy Pettapiece today renewed his call to protect municipalities facing mounting insurance premiums.

During the first week of the legislative session, Pettapiece introduced a new motion calling on the government to reform the joint and several liability model.

"Municipalities' insurance premiums are still too high," said Pettapiece. "No longer can this government ignore calls from our municipal partners. They need to work with them to reform this expensive system."

Currently, if two or more parties are found at fault or negligent in a lawsuit, damages can be recovered from any defendant—even if the party is deemed only one percent responsible. This is putting municipalities on the hook when other defendants lack the ability to pay.

Last February, Pettapiece introduced a private member's motion calling on the government to reform the joint and several liability model. His motion won statements of support from the Association of Municipalities of Ontario (AMO), the Insurance Bureau of Canada, insurance brokers, and over 210 municipalities across Ontario.

The motion passed with strong support from all parties in the legislature.

However, at the August 2014 AMO conference, Premier Wynne announced that her government would not be introducing any joint and several liability reform measures.

"It's very strange that the government supported my motion, but then six months later, refused to take action," Pettapiece commented. "The Liberals had been promising action since 2011, but then they reneged.

"Municipalities deserve better," Pettapiece added.

Pettapiece did not give up. He filed a Freedom of Information request to gather documents related to the Ministry of the Attorney General's consultations on joint and several liability.

"Municipalities are facing a liability chill," said Pettapiece. "Across the province, this has led to tobogganing bans and restrictions on public activities. No child should be banned from tobogganing because of the threat of a lawsuit."

# REDUCE, REUSE, RECYCLE

# THE THREE R'S HAVE CHANGED SINCE MOST OF US WERE KIDS

Head, Clara and Maria is a recycling community and the staff at the Township office work to find little ways to divert items from our landfill sites daily. Sometime we take the "garbage" and set it aside for a craft thinking we could use that to make a decoration or kids craft, or we save it to send to someone we know uses them to make a new product.

Well that is how it works for pop can tabs, stamps, Campbell's labels and milk bags. We collect these and pass them on to different organizations or school groups that collect larger amounts with the end goal of providing funds or a product to make someone's life easier. The following outlines what happens with some of these items and how you can help.

# **Saving Stamps**

Recently I received a thank you from "Effect Hope" The Leprosy Mission in Canada. Our community of HCM, had being bringing in stamps to our collection for about a year and I had finally took them home and trimmed them to the desire size and mailed them off.

The letter thanked us for this gift as they then take the used stamps and sell them to stamp collectors and Effect Hope receives money for their cause, eliminate Leprosy.



They need a pound of stamps to earn \$9.00 and raised \$14,500 in 2013 and are trying to raise \$12000 this year 2014. Next (2015) year's goal is unknown.

So I would like to thank everyone for bringing their old stamps in for this collection and encourage others to do the same. The side bene-

fit of this collection is another item that does not end up in our landfill...does not seem like a lot but every little bit adds up.

If you wish to bring the envelopes in whole I will trim to the correct size or you can just tear them in half and leave for me to trim. If you wish to trim stamps yourself they need to be

trimmed to a border of NO less than a ¼ inch all around. Personally I like to try and get closer to the ½" border. If you are in the process of going through old files etc., they would love stamps from letters dated prior to 1950 intact. Do not trim at all, but drop off the entire envelope to be sent to "Effect Hope", no trimming needed. Thank you all for your help. (Gayle Watters)

"Happy Spring Everyone, Just a few reminders regarding recycling and waste disposal.

- Old clothes and furnace filters are not recyclable.
- Recyclables must be placed out in clear plastic bags.
- Plastic and glass bottles should have the caps removed as they are a different grade of plastic from the bottles and need to be separated during sorting.

• The recycling container in Stonecliffe at the Municipal garage is not meant for electronics or furniture. These items must be brought to the landfill sites. Electronics are separated there and we receive a credit for them. Some furniture may be placed in the re-use area. Thanks for your cooperation, Bill Donnelly

And from the Clerk... as noted above, Bill has advised that some people are slipping and that it is evident that we are not all recycling as much as we could and should be. Sometime in the near future spot audits of both garbage and recycling will be returning. For those who are found to not be compliant Council has outlined in their Waste Management By-Law that fines may be levied and collection might be refused. If you are uncertain of rules, please just ask Bill or anyone at the office. We can provide you with a copy of the by-law. It is also posted on-line for those of you who have internet access.

And please remember our re-use area. Both sites have an area set aside for materials which may be re-used. It is often said that one man's trash is another's treasure... some gently used furniture may be the perfect fit for your deck, cottage or camp. Please consider this area when disposing of your used material and when looking for items. Every bit helps.
