I am in receipt of your email dated October 11, 2011. In that letter you asked three questions. The following are brief comments regarding these questions:

1. Does Council have any recourse over the damage that may have been caused by the untrue statements made by Mr. 2007.

The only recourse you have against an individual who makes untrue statements about you is pursuant to the Laws of slander. The Council itself would not likely be able to sue for slander, but individuals may sue if they have suffered damages. It is the damages portion of the Claim that would be very difficult in this case.

2. Am I are at a suffered through the direct and proper discharge of duties entitled to legal services as provided in the attached policy?

I reviewed the policy which you provided and I do not believe it covers this particular situation. Paragraph 1 of the Guidelines refers only to a situation where an employee might be sued as a result of his or her actions as a Municipal employee. These Guidelines do not speak to whether or not a lawyer will be provided to an employee who wishes to sue someone else, i.e. for slander.

3. Are there any issues you feel that Council as a whole or I should consider or actions we should take directly related to the situation?

The only issue that I can see is whether or not there is a limit as to the extent to which a tax payer can speak out at a public meeting. It is difficult to set Guidelines with respect to this as every situation is different. It may be that in some situations, aggressive and personal attacks on individuals should be cut off if there is little basis in fact in what the individual is saying. However, therein lies the problem of who determines on the spur of the moment what the facts are.



Subject: **Approval Process for Alternative Energy Projects**

The Township of Mulmur has experienced a number of situations where alternative energy installations, primarily smaller projects carried out under the MicroFit program, have not been carried out with required approvals and/or at locations which are appropriate.

We note that the Ontario Power Authority (OPA) and your Ministry have recently launched a review of the FIT and MicroFit programs, and we would urge you to take our concerns, as expressed below, into consideration as part of that review.

We believe that, at the very least, a protocol should be developed requiring input and comments from the local municipality on all such projects. In those situations where approvals such as building permits or Niagara Escarpment Commission development permits are required, we believe that the Ministry and/or the OPA must ensure that such approvals have been obtained and the conditions of approval have been satisfied.

The municipal Council of the Township of Mulmur, at its November 1, 2011 meeting, has passed the following resolution.

Moved by Hayes, Seconded by Hawkins:

THAT WHEREAS the Province has taken away from municipalities both commenting and approval authority for "green energy" projects;

AND WHEREAS the Township of Mulmur has recently had constructed, within a municipal road allowance, an unauthorized solar array;

AND WHEREAS some such facilities are being constructed without required building permits and/or other required approvals, such as Niagara Escarpment Development Permits;

AND WHEREAS such situations are examples of what can, and does all too regularly occur when appropriate checks and balances are not in place (which is clearly the case when consultation with, and the approval of the local municipality is not required);

NOW THEREFORE BE IT RESOLVED THAT the Province of Ontario be urged either to adopt a standardized compliance checklist of requirements to ensure that such facilities are being installed in an appropriate manner, and to be more diligent in their review/approval of such projects, or amend the requirements so that all such facilities are subject to a municipal consultation/approval process or, at the very least, a protocol for ensuring that such facilities are installed appropriately and in accordance with required approvals.

AND THAT staff be directed to circulate this resolution to other rural municipalities as directed by Council, with a request for support.

Since the County Plan is a due a revision under this requirement, County Council has authorized the Planning Division to update the County of Renfrew Official Plan. The various phases in the review process are attached. The revisions to the Plan that will flow out of this review would be implemented through an official plan amendment to be adopted by County Council and approved by the Ministry of Municipal Affairs and Housing.

Phase I of the work program is "Initial Consultation" which includes a survey of local municipalities that utilize the County Official Plan. As stakeholders in the Plan, we are interested in your views on where we can make improvements to the document.

To this end, we would appreciate it if you would review the questions below with your Council and appropriate municipal staff and provide us with your municipal response by December 31, 2011.

Questions:

- 1) Are there any new policies you would like added to the Official Plan?
- 2) Are there any existing policies you would like removed?
- 3) Are there any existing policies you would like changed or clarified?
- 4) Are there any changes to the map schedule affecting your Municipality that you would like considered (e.g., changes to any land use designations)?
- 5) Are there any other comments you wish to make concerning the Official Plan?

As a final note, we would like to stress that there will be a number of opportunities for local municipal input to this process. In addition to this survey, we plan to meet all affected local Councils to review and obtain comments on the draft official plan amendment. In addition, under phase 8 of the work program there will be 4 public meetings across the County on the proposed amendment to seek public input. If your municipality would like an additional opportunity for consultation, please call me.

OUTLINE OF PHASES November 2011

PHASE 1 – INITIAL CONSULTATION WITH MMAH AND SURVEY OF LOCAL MUNICIPALITIES

There are 3 parts to this phase: 1) County staff to develop a preliminary list of policy issues to be addressed in the update – this would also include preparation of demographic information for all of the County; 2) prepare a survey to be sent to the local municipalities who use the Plan to obtain their likes/dislikes of the Plan, and any suggestions or changes; 3) pre-consult with MMAH and partner ministries – County staff to make a presentation on our specific issues; ministries to bring maps/documents.

PHASE 2 - SPECIAL COUNCIL MEETING

This phase would comprise the holding of the Special County Council meeting under Section 26 of the *Planning Act* to consider revisions to the Official Plan. This will afford Council and the public the opportunity to identify issues and concerns and discuss any revisions to the Official Plan that may be required.

PHASE 3 - PREPARATION OF STAFF DRAFT OFFICIAL PLAN AMENDMENT (OPA)

The revisions to be made to the Plan, both text and map, would be incorporated into an OPA document.

PHASE 4 – CIRCULATE STAFF DRAFT OPA TO MMAH

The draft OPA would be circulated to MMAH for comment. This step includes a review of provincial comments in a meeting with County staff, MMAH and any required partner ministries.

PHASE 5 – COMMITTEE/COUNTY COUNCIL REVIEW AND APPROVAL OF DRAFT OPA

The draft OPA and provincial comments would be presented to the Development & Property Committee and County Council for acceptance. (MMAH may have to be present at one or both of these meetings.)

PHASE 6 - PROVINCIAL/LOCAL MUNICIPAL REVIEW OF APPROVED DRAFT OPA

The approved draft OPA would be circulated to the Province for review and presented by County staff to all affected local municipalities (10).

PHASE 7 – PREPARATION OF FINAL DRAFT

Based on the comments from Phase 6 above and meetings with Committee and Council, changes would be made to the Approved Draft to create the Final Draft.

PHASE 8 – PUBLIC REVIEW OF FINAL DRAFT

Four public meetings across the County would be held to seek input on the Final Draft.

PHASE 9 - ADOPTION OF OPA AND SUBMISSION TO MMAH

Staff to report back to Committee who would then make recommendations to County Council. County Council would then formally adopt the OPA and submit to MMAH for approval.

On November 2, 2011, the Municipal Property Assessment Corporation (MPAC) will begin delivering nearly one million Property Assessment Notices to property taxpayers across the province.

While the next province-wide Assessment Update will take place in 2012, changes to properties continue to occur. New homes and additions are built, owners renovate, structures are removed or demolished and properties change use. MPAC is legislatively responsible for updating this information even in a year when a province-wide Assessment Update is not taking place.

Some of the reasons for receiving a Property Assessment Notice this fall include:

- a change to property ownership or legal description;
- a change to the property's assessment resulting from a Request for Reconsideration (RfR) or Assessment Review Board decision;
- a property value increase or decrease reflecting a change to the property, for example, a new structure, addition, or removal or demolition of an old structure; or.
- change in the classification or tax liability of a property.

Each Notice shows the assessed value and classification of a property based on the legislated valuation date of January 1, 2008, which is in place for the 2009-2012 property tax years.

Although each Notice also indicates a number of ways to contact MPAC, you may also receive enquiries. The enclosed information kit will help you and your staff respond.

a copy of the Information Insert included with every Notice;

Important Information About Your Property Assessment brochure; and,

a fact sheet about MPAC.

This past spring, our government launched Ontario's first 10-year long term infrastructure plan, *Building Together*. Through this plan, which I announced as Minister of Infrastructure, the province will continue to make significant investments in public infrastructure over the next decade. This includes more than \$35 billion over the next three years, including \$12.8 billion in 2011-12. These investments are projected to create and preserve over 300,000 jobs. Building Together also focuses on better asset management planning and the expansion of Infrastructure Ontario to deliver more projects in collaboration with municipalities as well as the broader public sector.

Building Together aligns with other initiatives that are building a better quality of life for all Ontarians. This includes the Growth Plan for the Greater Golden Horseshoe, a 25-year plan to manage growth in the region. I remain committed to ensuring that Ontarians enjoy healthy, sustainable and prosperous communities through good growth management and am pleased with the advances we have made. In July, the Ministry of Infrastructure marked the growth plan's fiveyear anniversary by releasing a progress report. While we are still in the plan's early years, many indicators show that its policies are having a positive effect. Building Together also aligns with the Growth Plan for Northern Ontario, a 25-year plan released in March 2011. The plan will create a strong, sustainable Northern Ontario with communities that attract people and investments, support education and employment opportunities, and position the northern economy to compete on a global scale. The Ministry of Infrastructure and the Ministry of Northern Development and Mines are working together with other provincial ministries to ensure that Ontario's programs and investments align with the goals of the Growth Plan and support a strong Northern Ontario. As part of the Growth Plan for Northern Ontario, 2011, the Ministry of Transportation is developing a Northern Ontario Multi-modal Transportation Strategy to provide direction for transportation infrastructure in the North over the next 25 years. It will include all modes of transportation -- air, rail, road (including winter roads) and marine.

As Minister for both Transportation and Infrastructure, I am going to continue to rely on the advice and counsel of our partners in the construction, design, finance, and other sectors, including Ontario's trades, as well as the advocacy and planning perspective of Ontario communities and municipal partners. I foresee a dynamic partnership between these two ministries that will – with your continued support and advice – deliver the quality public infrastructure that all Ontarians deserve and expect.
