RE: Highway 17 Expansion

Please be advised that Council of the Corporation of the Town of Petawawa passed the following resolution at its meeting of November 17, 2014:

Resolution #4 (November 17, 2014)

MOVED BY: Theresa Sabourin SECONDED BY: James Carmody

WHEREAS in order to be a strong, diversified and healthy community, the County of Renfrew must be served by an efficient road transportation system as public transit is not available and railway service and infrastructure has been abandoned;

AND WHEREAS the demand exists for a safe, accessible and efficient transportation corridor through all of the County of Renfrew;

AND WHEREAS the accelerated extension of Highway 417 is required to provide the infrastructure necessary to promote sustainable economic and community development;

AND WHEREAS the extension of Highway 417 is proceeding at a slow pace through the County of Renfrew from the Township of McNab/Braeside westward;

AND WHEREAS over 53% of the population of the geographic County of Renfrew is located within the Highway 17 corridor between the Townships of Head, Clara and Maria and Whitewater Region;

AND WHEREAS travel safety, the flow of traffic and wear and tear on commercial vehicles are all compromised by 10 light-controlled intersections on Highway 17 from Deep River to Cobden;

AND WHEREAS the Ministry of Transportation has already assembled most of the right of way land for expansion of Highway 17 from Chalk River to Petawawa;

AND WHEREAS Highway 17 is an integral part of the Trans Canada Highway, a core route in the National Highway System, a vital network in support of Canada's economy and a critical transportation corridor for all Canadians;

AND WHEREAS the Highway 17 corridor between the Townships of Head, Clara and Maria and Whitewater Region serves over 10,000 civilian and uniformed personnel employed at Garrison Petawawa and Canadian Nuclear Laboratories Limited. These two pre-eminent federal institutions generate significant commuter traffic, commercial shipments and military convoys;

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the Town of Petawawa request that the Ministry of Transportation consider commencement of the four lane expansion of Highway 17 eastward from North Renfrew to meet westward construction when it eventually reaches the midpoint of the corridor near Cobden:

AND FURTHER THAT the Province of Ontario consider this four lane expansion of Highway 17 as a project of major federal and regional significance that is vital to sustaining economic growth and enhancing the quality of life of Canadians and pursue funding partnership opportunities through Government of Canada infrastructure programs;

AND FURTHER THAT a copy of this resolution be sent to Kathleen Wynne, Premier of Ontario, Steven Del Duca, Minister of Transportation, John Yakabuski, MPP Renfrew-Nipissing-Pembroke, Cheryl Gallant, MP Renfrew-Nipissing-Pembroke, County of Renfrew, Townships of Head, Clara and Maria, Laurentian Valley and Whitewater Region, Towns of Deep River and Laurentian Hills and City of Pembroke.

The **Ontario Sport and Recreation Communities Fund (OSRCF)** is a grant program that supports a vision of getting and keeping Ontarians active in community sport, recreation and physical activity. The fund:

- increases opportunities for participation in sport and recreation by developing new programs or increasing access to existing programs to encourage individuals to become more active and keep those who are, engaged throughout their lives
- supports implementation of physical literacy as a foundation for lifelong physical activity among individuals enabling them to make healthier activity choices
- strengthens the community sport and recreation sector by providing training in areas such as coaching, youth development, and volunteer development to provide enhanced service and quality programming.

Through the support of projects that deliver high-quality programs and policies, the OSRCF provides Ontarians with more opportunities to become physically active, including groups who experience barriers to participating and those who are traditionally less active.

The program supports projects of one or two years in length, at both the Local/Regional and Provincial levels.

# Who Can Apply?

Incorporated **not-for-profit organizations** that can offer high-quality sport, recreation and physical activity programs and have operated and been incorporated for at least one year in Ontario (this includes **First Nations** and municipalities).

## Funding Criteria - Cost-sharing Requirements

The Ministry will fund a percentage of eligible project expenses requested by the applicant:

- Projects serving First Nations and municipalities (as defined by the most recent Census Canada data) with a population greater than 20,000 can receive up to 60 per cent of eligible project expenses.
- Projects serving First Nations and municipalities (as defined by the most recent Census Canada data) with a population less than 20,000 can receive up to 80 per cent of eligible project expenses.

All applicants must make a cash contribution of at least 10 per cent of eligible project expenses. Remaining expenses can be covered by the applicant and/or its project partners as additional cash and/or in-kind contributions. Contributions that come from other sources such as project funding from other ministries or grants from agencies such as the Ontario Trillium Foundation are not eligible as cash or in-kind contributions.

Before You Apply - Consult With Us First!

Consultation with the appropriate Ministry contact before submitting an Application Form is expected. This should be done at least 3 weeks before the application deadline. This consultation will help determine whether the applicant and proposed project meet the eligibility requirements of the OSRCF and will provide guidance in the development of your application. Consultation means a dialogue, in writing or over the phone, in which the applicant provides detailed information on their proposed project. Please note: consultation does not mean a project will be recommended for funding.



## Improving Community Transportation for Seniors, Persons Living With Disabilities

November 25, 2014

#### New Program Will Help Keep Everyone in Community Moving

Ontario is launching a new pilot program to improve community transportation services for seniors, persons living with disabilities, youth, and other members of the community who need transportation.

The Community Transportation Pilot Grant Program will provide funds to municipalities to partner with community organizations, such as health and community agencies, transit agencies, school-bus operators and private transit operators, to co-ordinate local transportation services, so more rides can be provided to more people, and to more destinations.

For example, municipalities and organizations will have the ability to co-ordinate vehicles and drivers to provide rides to more clients from multiple organizations, such as community and social health services, to a common destination. This helps free up other vehicles to make trips to other destinations or to offer rides to the broader public.

This program is part of the Ontario government's commitment to provide support to help seniors stay healthy and stay at home longer. It will also improve transportation services, options, and resources for everyone in the community, such as students and youth who need to get to school, persons with disabilities, or those in rural areas where amenities and services are too far to reach without a car.

Investing in public transportation is part of the government's economic plan for Ontario. The four part plan is building Ontario up by investing in people's talents and skills, building new public infrastructure like roads and transit, creating a dynamic, supportive environment where business thrives, and building a secure savings plan so everyone can afford to retire.

- Over the next 20 years, the number of seniors aged 65 and over will more than double, from 1.9 million today to 4.2 million in 2036.







# Legislative Update

With the legislature back in full swing, November has been a busy month for the municipal sector in Ontario. Over the course of November, the government has provided updates on the province's fiscal outlook and moved forward on several pieces of legislation with implications for the sector.

Here is a summary of the most relevant developments from the past month:

Parliamentary Assistant Mandate Letters Released: The provincial government has released the <u>mandate letters</u> that Cabinet Ministers write to their Parliamentary Assistants, following the publication of <u>similar letters</u> from the Premier to her Ministers in September. Of interest to AMCTO is <u>the letter</u> from the Honourable Minister of Municipal Affairs and Housing Ted McMeekin to his Parliamentary Assistant Lou Rinaldi, instructing him to contribute to the review of the Municipal Elections Act (MEA).

Ministry Considering Changes to Conflict of Interest Act: A spokesman for the Ministry of Municipal Affairs and Housing (MMAH) <u>has confirmed</u> that the Ministry is considering changes to the Municipal Conflict of Interest Act (MCIA). The current conflict of interest regime has come under fire following several recent political scandals.

**Province Provides Fall Economic Update**: Ontario's Minister of Finance, Charles Sousa, delivered the province's fall economic update this month. Highlights from the Minister's update include a commitment to reforming the provincial land tax in unincorporated territories and \$50 million in new Ontario Community Infrastructure Fund (OCIF) formula allocations for municipalities with populations below 100,000. Accessibility Directorate Launches New Campaign: The Accessibility Directorate of Ontario (ADO) launched a new campaign in November to help inform businesses across the province about their obligations under Ontario's accessibility legislation, the *Accessibility for Ontarians with Disabilities Act*. The campaign, which will run until December 15, 2014, includes a new website to simplify and clearly communicate accessibility requirements.

# Bills and Lawmaking

Bill 8, the Public Sector and MPP Accountability and Transparency Act, continued its steady passage through the legislature in November. See this month's policy spotlight (below) for more information on Bill 8.

Bill 39, the Planning Statute Law Amendment Act, includes a provision that may pave the road for municipalities to post electronic planning notices, rather than publishing them in print. On November 20, Bill 39 passed its second reading and was sent to the Standing Committee on General Government. Though the ultimate implications of the Bill are not clear, AMCTO will use this opportunity to advocate for eliminating the current planning notice paper publication requirement, an archaic regulation that places an unnecessary financial burden on municipalities.

# **Regulatory Changes**

**Lac-Mégantic Prompts New Rail Safety Regulations:** The federal government introduced new rail safety regulations in November. These new regulations came in response to the tragic Lac-Mégantic train derailment last summer as well as recommendations from the Transportation Safety Board of Canada (TSB) and requests from a number of municipalities. # Policy Spotlight: Bill 8, the Public Sector and MPP Accountability and Transparency Act

Bill 8, the *Public Sector and MPP Accountability and Transparency Act* is a piece of legislation that gives the Ontario Ombudsman oversight authority over municipalities. First introduced at the beginning of July, the Bill currently being studied by the Standing Committee on General Government, prior to a third reading and royal assent.

A number of stakeholders, including Toronto Ombudsman Fiona Crean, and AMO have appeared before the committee to voice their concerns. AMO's reservations to the Bill were also communicated in a <u>statement</u> earlier this month, in which they affirmed that despite their support for the spirit of transparency and accountability that the Bill promotes, they have reservations that it will not be implemented in a cooperative or respectful manner.

In March of 2014, <u>AMCTO expressed its own concern</u> about the introduction of this Bill. These reservations continue to exist. AMCTO is particularly concerned that there has been only minimal engagement with the municipal sector about the perceived deficiencies within the current accountability system, and unclear justification for why these perceived deficiencies would necessitate the creation of an additional layer of provincial oversight, as proposed in Bill 8.

If passed, AMCTO will support its members with the implementation of this new legislation and provide any required managerial or technical training, as well as any other necessary support to ensure its effective implementation. As municipal professionals, AMCTO members are committed to enhancing effective local government management without creating additional layers of oversight that could lead to inefficiencies for local ratepayers.
