AND WHEREAS CP Rail has transferred administration of that crossing lease to the County of Renfrew in consideration of the eventual purchase of the rail corridor;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby support the Elder's in their request to the County to waive the lease fee indefinitely for the continued use of their access to their private property over the abandoned rail corridor.

To whom it may concern,

In 2011 the County of Renfrew, County of Lanark and the Township of Papineau-Cameron (the Partners) initiated discussions with Canadian Pacific (CP) Railway to acquire the abandoned rail corridor to ensure that it remained in the public domain for the creation of a multi-use, four-season trail system. The rail corridor is a total of 296 km in length, commencing in Smiths Falls and ending in Mattawa, Ontario. In 2016 the Partners signed and purchased the rail line from CP. The rail line was officially named the Ottawa Valley Recreation Trail to reflect the inclusiveness of the wide geographic location of the trail and the County of Renfrew subsection was named the Algonquin Trail.

As part of the agreement for sale of properties CP has provided us with the attached Notice and Direction to Licensees from CP Rail Company which authorizes the County of Renfrew to receive rent, fees and other payments under your agreement commencing April 1, 2017. Please make all future lease payments in accordance with your agreement(s) to the Municipal Corporation of the County of Renfrew.
