



After careful consideration, the Canadian Red Cross will be closing the branch office located at 1217 Pembroke Street East, effective July 1, 2016. Because of changes in the way our programs and services are delivered at this location, a branch office is no longer required.

All Red Cross services currently offered to Renfrew County& District residents will continue to be provided but a physical building is not needed to continue to operate these programs. The exceptions to this is the Health Equipment Loan Programs program and the Knitting Program, which will no longer be operated by the Red Cross in Renfrew County.

We will continue to have supplies pre-positioned in strategic areas across the province that are readily accessible in the event of an emergency. Based on feedback received from many municipalities, and in keeping with our renewed commitment to educate, inform, and be transparent on OPP municipal policing billing practices, the OPP will be posting the 2015 and 2016 policing costs for all OPP policed municipalities on <a href="https://www.opp.ca/who.we.are/Municipal Policing Bureau">www.opp.ca/who.we.are/Municipal Policing Bureau</a>.

#### Municipal portal initiative

We are currently at the design stage for creating a communication portal with all 323 municipalities policed by the OPP. The ability to communicate regularly and in a timely manner with such a large number of clients using conventional means, like regular mail, has its limitations. In keeping with the OPP's drive to innovate and be more efficient, my intention is to develop an online correspondence delivery system that allows all of us to communicate with you in a more efficient and effective way.

This online portal will have individual municipal access and serve as a delivery mechanism for all the correspondence with municipalities like yours going forward. i.e. annual billing statements, letters, reminders etc.

#### The OPP Contract Proposal Process

As you are aware, the Ministry of Community Safety and Correctional Services lifted the moratorium on costings on November 1, 2015 and the OPP has started providing contract proposals as requested. There are currently 10 municipalities in the queue for costing proposals. The contract proposal process was designed not to affect the municipal policing cost of the existing OPP-policed municipalities. d) Unfair Treatment of Children with Autism Spectrum Disorder and Their Families

Moved by Councillor McLean Seconded by Councillor Brenner

Whereas the Provincial Government and Ministry of Child and Youth Services announced \$333 million over five years for Autism Spectrum Disorder (ASD).

Whereas eliminating a wait list for Early Intensive Behaviour Intervention (EIBI) for the youngest children means families will have access to important treatment sooner. However families who have been on the waiting list for Intensive Behavioural Intervention (IBI) services for many years are being doubly penalized by not having had access to the best early intervention for their children and by learning they will now not receive this service by being discharged from the waiting list.

Whereas IBI therapy costs roughly \$50,000 per year, per child. For the many children who are now being taken off the wait lists or phased out of programs, the service will be replaced by a one-time funding of \$8,000 per child, equivalent to roughly two months of IBI therapy, to obtain services while transitioning to school and public supports – services that are not related or compare to IBI.

Whereas concerns from Autism experts, service providers and other advocates, condemn the government's new strategy.

Whereas as with these proposed changes in funding, the Province has acted in a manner contrary to the values of Ontarians "the value that Ontarians place on caring, supporting and investing in the most vulnerable members of our community" and is acting contrary to the United Nations Charter of Rights of Persons with Disabilities, "persons with disabilities have the right to the enjoyment of the highest attainable standard of health without discrimination on the basis of disability" and also states that people have a right to the services specifically required for the management of their disability. These clauses are inclusive of all people, not just the ones the government sees fit.

Whereas other advocates expressed profound disappointment that the new "autism strategy" announcement contained no details whatsoever for either school or adult programs.

Now therefore be it resolved that the Council for the City of Pickering:

- 1. Stress to the Government of Ontario and the Ministry of Child and Youth Services the immediate need to reinstate adequate funding for children in need of IBI Therapy regardless of age.
- 2. Provide copies of this motion to The Honourable Kathleen Wynne, Premier of Ontario, The Honourable Tracy MacCharles, Minister of Child and Youth Services, MPP, Patrick Brown, Leader of the Conservative Party of Ontario and MPP, Andrea Horwath, Leader of the Provincial New Democratic Party.
- 3. And copies to be forwarded to Durham Regional Council, York Regional Council, Peel Regional Council and the City of Toronto requesting endorsement of this motion.

## Bill 181, The Municipal Elections Modernization Act 3rd Reading

AMO was disappointed to learn that a government amendment to Bill 181, *The Municipal Elections Modernization Act* will ban corporate and union donations in all municipal election campaigns without a simultaneous increase in the limit for individual donations. There are concerns that such a move, without an increase in the donation limit, will make fundraising much more difficult for some municipal government candidates in the shortened nomination/campaign period.

AMO President Gary McNamara presented to the Standing Committee on Thursday, May 12, 2016. The comments delivered by AMO's President stressed that municipal governments are a mature and accountable order of government in Ontario that can and should be trusted to engage with our residents and stakeholders to make decisions in the best interests of our communities. Elements of AMO's submission include:

- Leaving the Bill as is so that the decision to change to ranked ballot voting in a municipal election to the local council in consultation with the community, without a mandatory referendum;
- Shortening the campaign period with the ability for candidates to take on fundraising activities once nominations are filed;
- Municipal council choice to ban union and corporate donations;
- · Tiered penalties for late filing of election financial statements; and
- Flexibility to set the first council meeting after an election to accommodate transition which can be different between rural and urban municipal governments.

In advance of President McNamara's appearance, there were some persistent rumours of a province-wide ban on corporate and union donations in municipal elections. To address this, AMO advised that it would make fundraising more difficult in some councils' positions where candidate spending limits are in the hundreds of thousands and that an increase in the individual donation limit should also be made if a ban was implemented. There was no amendment to do this. As such, the \$750 contribution limit within the more constrained fundraising period in the Bill, making securing adequate funds for urban candidates much more challenging.

In the end, Bill 181 proposes some major changes for how Ontarians vote for their local councils. These changes will be judged by how they are implemented during the next election and their impact on the election process. Unlike other elections legislation, the *Municipal Elections Act* is reviewed regularly after each municipal election. The Bill has not been reported to the House as yet for Third Reading debate. AMO will continue to track the Bill.

### AMO Seeking Clarity on Ontario Climate Change Action Plan

Municipal governments in Ontario and beyond have been strong advocates of environmental quality and climate action for decades. Municipalities know that climate change has resulted in more frequent and intense storms that wreak havoc on our infrastructure systems and the economic prospects of residents and our communities and have taken local action to reduce their own emissions and increase resilience.

However, recent reports in the news media, purportedly from the government's proposed Climate Action Plan, have raised important questions for municipal governments, particularly as they relate to natural gas. Seemingly leaked documents have suggested that one major aspect of the province's Climate Action Plan will be to no longer provide natural gas as a heating source in new buildings starting in 2030, which then triggers concerns and questions about the current expansion of natural gas services.

Many communities in Ontario are looking to the expansion of natural gas and the \$200 million provincial program that enables it, as a welcome economic opportunity to reduce consistently high electricity prices for these communities and support economic development in a meaningful way. Municipal governments are working to put their financial resources to work for the expansion and for some this may include taking on debt. The media reports of a substantial increase in price along with what appears to be a change in direction are confusing our membership.

Because the Climate Action Plan has not been made public, we cannot confirm its details. However, AMO has called on the government to fully clarify the policy intent for natural gas expansion. We have called upon the Premier and the Minister to do this sooner than later. Municipal governments, rural or urban need to understand how Ontario's energy system will support and attract local economic development. Energy costs are sited as a barrier. Reducing greenhouse gas emissions is a requirement for our environmental and economic security. But we need to transition in a way that supports a vibrant economy and one with a solid foundation.

Given today's passage of the *Climate Change and Low Carbon Economy Act* (Bill 181), we are not aware of any barriers to the release of the Climate Action Plan, along with the full analysis of all the impacts. AMO has written to the Premier and the Minister requesting this action. Clarity is needed now.

# HISTORIC SIGNING BETWEEN COUNTY OF RENFREW AND ALGONQUINS OF PIKWAKANAGAN FIRST NATION

At the May session of County Council, Warden Peter Emon, along with Algonquins of Pikwakanagan First Nation Chief Kirby Whiteduck signed a Memorandum of Understanding (MOU) that creates a framework in which both parties will work together on key issues. Specifically, the MOU outlines key areas of common interest — infrastructure and economic development, training and business opportunities, and skills development. A united position on these issues works to the betterment of both Renfrew County and the Algonquins of Pikwakanagan First Nation.

The next step is the establishment of a Working Group made up of designated representatives from the Algonquins of Pikwakanagan First Nation and the County of Renfrew. The Working Group will be tasked to identify priority areas for collaboration and action, such as the CP rail to trail program, the extension of Highway 417, promotion of Algonquin training opportunities through Enterprise Renfrew County, cooperation to enhance business and economic development opportunities, and any other priorities as identified and agreed upon by the Working Group. In addition the Working Group will produce an on-going work plan that will include activities and actions that relate to the priority areas identified through collaboration.

Although the parties acknowledge that the MOU doesn't create a legally enforceable or binding obligation, both parties have developed this MOU in the spirit of mutual respect and cooperation for the benefit of all their residents.

Warden Peter Emon shared this comment, "By signing this document today, we enter into a new and exciting phase of our growing relationship with the Algonquins of Pikwakanagan First Nation. This collaboration will provide both parties with opportunities that will ensure the continued prosperity of all persons and will strengthen the ties between us."

Chief Kirby Whiteduck stated that, "The Chief and Council, on behalf of the Algonquins of Pikwakanagan First Nation, are very pleased to be signing this MOU with the County of Renfrew. We look forward to working more diligently with the County of Renfrew in the areas of economic development, employment and training. We are pleased to partner with our neighbours in these and other areas of mutual interest".
