## **Deputations/ Presentation**

### County of Renfrew

Bruce Howarth, Manager of Planning Services

There have been many changes over the years that municipalities have asked the County to assist with and/or undertake; reaching out to local municipalities to provide stability for the Planning Department. Happy to bring enough staff in to assist. Reaching out to see what needs of municipalities are and ensure that those needs can be fulfilled. County wants to ensure efficient processing of applications and clear understanding of roles; reducing duplication of efforts.

These planning agreements concern local planning approvals only; no changes for consent applications, Zoning By-law amendments, minor variance etc.

Not a lot of requests in Head Clara and Maria, however County Council asked that all local municipalities be invited to participate.

### **Zoning By-Law Workplan**

Local approval that township is responsible for. In 2021 County Council finalized Official Plan which triggered three-year timeline for municipalities to update their plan to conform with the updated County of Renfrew Official Plan. County sent out workplan to all local municipalities who use their Official Plan to see if they would like assistance in their updates.

A template has been created that is consistent across all areas, but can be tailored to meet specific needs of individual municipalities. The workplan also includes update to mapping. Head, Clara and Maria does not have mapping in their plan. We would be able to update zoning schedules for ratepayers that can login and search their property and zoning information – can cross onto other local municipalities.

Councillor Villeneuve – County definition of lot size is not a good fit for Head, Clara and Maria. Current says one acre; County Official Plan says 2.5 acres. 1.5 acres is plenty for rural property with its own septic and well. Rural properties are different from town/village – zoning by-law should reflect that.

Bruce Howarth – Official Plan vs Zoning By-law. Official Plan does not require 2.5 acres. Private servicing under 2.5 acres and want to create new lot; hydrogeological study to support that a new well and septic will have no impact on adjacent owners – either from the severed or retained lots. If over 2.5 acres study is not required. Minimum requirement is still one acre.

Councillor Villeneuve has concerns with the process – will be sending letter to the County to address his concerns.

Councillor Dowser – when talking about digital mapping – similar to MPAC? Anyone can go in and see who owner is?

Bruce Howarth - Cannot access property owner information – zones, Official Plan designations etc. only.

All plans can be tailored to meet specific needs while meeting Official Plan requirements.

Mr. Jim Beaudin

Council's consideration of installing a municipal boat launch in Bissett Creek.

Would like to see more water access; issues with launching boats. Right now, need someone to pick up and drop off vehicles in Deux Rivieres.

Councillor Kelly-Chamberlain – is there access? There is a road near Trapper's Way. The municipality owns the property.

Councillor Villeneuve – went on GIS mapping to see property. Mapping shows that it is private property. Unopened Road Allowance – Council would need to build a road – costs a lot of money.

Mayor Grills – very proud of the boat launches that we have. Would like to find out more information about the property, appreciate bringing it to Council's attention.

Councillor Allen – Most people have to drive to boat launches. We can look into the details – who owns property etc. Preliminary questions would give green light or not.

Mr. Beaudin: If there is a breakdown on the water – no way to get boat launched/ out.

Clerk: Process would involve speaking with County of Renfrew regarding access across the railbed. The Unopened Road Allowance is owned by the municipality – would need to bring up to standard. Would also need to speak with Ontario Power Generation regarding a lease agreement to access their property abutting the water.

Mayor Grills: Do not enter onto private property without permission.

Mr. Beaudin: Also requesting that a "No Exit" sign be installed at McIsaac Drive.
